"Director of First Impressions"

The waiting room host serves a vital role at West County Health Centers and is often the first impression for patients walking through our doors. We want our patients and their families to feel welcome and comfortable during their visit to our health centers. Your job as a waiting room host is to greet patients with a smile, make them feel welcome, and help create a warm and comfortable environment in the waiting room.

It is important to be sensitive to individual patient needs for privacy and know that not everyone will be open to interaction with those around them. Offering a friendly face, a glass of water, or knowing when <u>not</u> to approach someone are all keys to being a successful waiting room host.

Below are ways you can help make our waiting rooms a warm and welcoming place:

- Offer a friendly, welcoming smile
- Being sensitive to body language knowing when to and not to approach someone
- Assisting with completing paperwork
- Offering a glass of water
- Resource guide introduction
- Voter registration and advocacy
- Keep the waiting room neat
- Update & straighten bulletin boards
- Keep educational pamphlets stocked
- Read to children

A variety of activities help WCHC carry out the goal as outlined above. These may include but are not limited to:

 Waiting room host – welcome patients to the health center; assist patients with paperwork, provide information about community resources and WCHC services.

Qualities and Expectations:

WCHC Volunteers are a valued part of our team. We welcome volunteers who embrace WCHC's mission and represent us in the following ways:

- · Have the ability to work with diverse populations

Requirements:

Our volunteers are members of the communities of west Sonoma County. No experience is required and training is provided. Volunteers must be able to:

- Physically carry out the duties assigned
- Have reliable means of getting to volunteer activities on time
- Pass a background check

Time commitment:

- Volunteers are asked to commit to at least six months of volunteer work and six activities per year.
- Volunteers are required to attend an eight hour orientation and training.
